**Re: Notice of Proposed Real Property Disposition – 1301 Mitchell Drive, St. Helena**

Dear Tribal Leader:

We are writing to notify you that Pacific Gas and Electric Company (PG&E) plans to sell a vacant property in downtown St. Helena. Located at 1301 Mitchell Drive, the property consists of ±0.88-acre of vacant land. The enclosed Property Information Sheet provides additional factual background relating to the property. PG&E is disposing of the property because it was formerly a manufactured gas plant, however, it was dismantled in 1930, then used as an electrical substation that was also removed. The parcel has been vacant since 1989 and it is surplus property.

A record search of the California Native American Heritage Commission's Sacred Lands File has identified the above-referenced property to be within ancestral territory of the Cortina Rancheria - Kletsel Dehe Band of Wintun Indians. We are providing this notification consistent with the requirements of the California Public Utilities Commission's (Commission's) Land Disposition Policy adopted December 5, 2019, *Investor-Owned Utility Real Property-Land Disposition – First Right of Refusal for Disposition of Real Property Within the Ancestral Territories of California Native American Tribes*.<sup>3</sup> Under this Land Disposition Policy, the tribe is provided a right of first refusal on the real property before PG&E may put the property on the market.

In accordance with the Land Disposition Policy, the tribe has ninety (90) days to respond to this notification as to its interest in acquiring the property by providing a written offer. PG&E supports the Commission's objective of ensuring tribal interests are appropriately considered in any sale of its property. For this reason, we are offering to consult with the tribe regarding its interest in acquiring the property within the 90 days. In addition, we appreciate any input, comments or information you would like to share regarding any cultural resources that may exist on the property. We will ensure your input is provided to the Commission as it reviews any future disposition of the property.

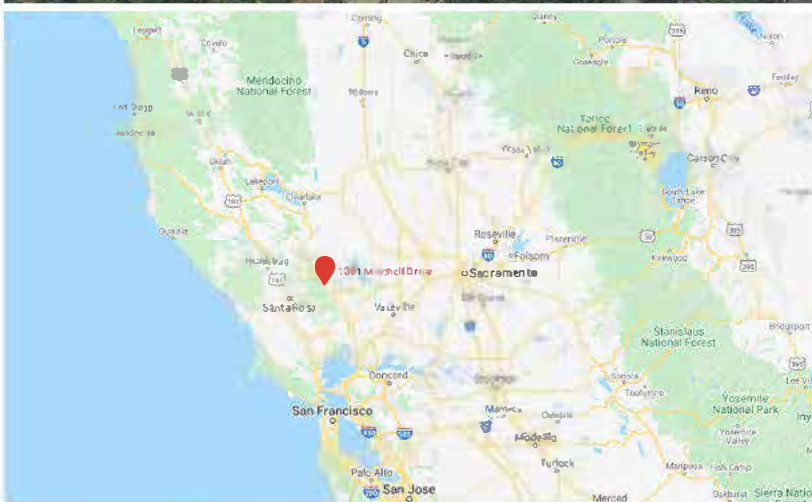

### Property Details

**±0.88-acre vacant irregularly shaped parcel.**

**Location:** Situated in the commercial business district of downtown St. Helena.

**Napa County**

**Zoning:** Northern portion: CB (Central Business); southern portion: BPO (Business and Professional Office)

**General Plan designation:** The City is updating its General Plan designation for the property. The proposed designation is Public Quasi-Public.

**APN:** 009-263-005

**Description:** The property is in a commercial area of St. Helena. Located between residential and commercial areas, it is vacant with a level gravel surface.

**Environmental:** Environmental remediation was completed in 2014 and groundwater monitoring is ongoing.

**PG&E Facilities:** There is an electric distribution line which requires an easement.

**Restrictions:** A 30' access easement for the adjacent property crosses the center of the parcel. A Land Use Covenant related to the former manufactured gas plant restricts certain activities.

**Other Notes:** The property is the site of a former manufactured gas plant that was decommissioned and remediated.

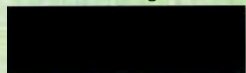
